- Student Travel Grant Management has been some confusion proposing a procedure where the conference pays the checks Alicia is the contact for this this will reduce PELS staff workload
- Data sharing with Google Drive each TC will have a coordinator for communicating with people in China.
   A small committee will decide data storing protocols (4 people from TCs the Chair and Alicia). China options may include using Baidu Cloud and synchronizing with Google; the committee will work with CPSS to find the best option.
- TC Structure Discussion an Adhoc committee was formed, members include Yan-Fei, Don Tan, Braham Ferreira, Brad Lehman and Robert Pilawa-Podqurski. Criteria for creating a new TC is there must be a flagship conference, represent future technology and have a group of core people. A new TC will graduate from TC6 generally.
- To sunset a TC AdHoc committee to determine if the TC will convert to a technical thrust in a TC, convert to a working group, etc.
- ECCE 2019 update includes promotion and review of the technical program; and, budget and additional segments for the EBL final competition of 23 teams.
- Focus of activities for ECCE 2019 includes the technical program, growth of exhibition, a better location for exhibition, more value, more accurate budget forecasting/control and best support of EBL.
- TC1 Summary reviewed. TC2 Summary reviewed. TC3 Summary reviewed new election in summer 2019 with new members starting in Jan 2020. A technical Achievement award is planned for 2020. TC4 Summary reviewed. TC5 Summary reviewed which included a new thrust structure. TC6 Summary reviewed. TC7 Summary reviewed noting there is a change from Tradition Telecom to Communications Power Systems. IFEC locations reviewed, impact through the year's shows IFEC engages more than 1000 of the most talented undergraduate students and many enter the power electronics field.

Need to have some consistency in how much the travel grants are TC to TC and Conference to Conference. A cap needs to be established. Have a committee to establish the guidelines.

- Membership Status year over year reviewed. Positive trends 2018 reached 9835 10,000 seems achievable for 2019.
- IEEE uses August data (which has PELS at 9185) an 8.2% increase in 2018.
- Reviewed the established framework, which may relate to the positive membership increase.
- Organizational structure reviewed.
