Author Guidelines: IEEE Transactions on Transportation Electrification (01-2024)

Manuscript Submission:

Prospective authors are invited to submit original contributions or survey papers for review for publication in TTE. All manuscripts must be submitted through <u>ScholarOne Manuscript</u>.

Papers submitted for consideration should report on original results not previously presented in any other archival publication, including but not limited to any IEEE Transactions. Notwithstanding this requirement, papers previously presented and published in a Conference Record or Proceedings sponsored by any of the sponsoring IEEE societies of TTE (IAS, IES, PES, PELS, RS, VTS) will be considered (provided that the paper is significantly improved when compared with the conference version of the paper). Copyright release may be required if the conference publication is copyrighted by an entity other than IEEE. It is the responsibility of the authors to obtain a copyright release if required for submission to TTE.

It is not required for a paper to have been presented or published at a conference to make it eligible for consideration by TTE.

Authors must indicate in their submission any prior presentation and publication at a conference, or prior submission to any other publication.

TTE only publishes papers in English. Inadequate English or the use of other languages obscure the technical content of the manuscript and will be grounds for rejection. It is therefore the responsibility of authors to ensure that papers submitted for review are formulated in acceptable English.

Manuscript Format:

From January 2023, all submissions should follow the double-column and single-spaced format; all submissions using a different format will be returned. Author biographies, photos, and copyright form should not be included in the original submission.

The paper should be prepared based on letter-size paper (either 8.5" x 11" or A4 sizes), according to the official TTE template that can be downloaded (in Word and LaTeX formats) from the IEEE Template Selector.

Please remove authors' biographies and photos if the template includes this section.

Please use standard fonts such as Times Roman (serif), Helvetica (sans serif), and Symbol. Unusual fonts may create incompatibilities that delay processing. Do not include page or line numbers in the uploaded file. ScholarOne Manuscripts will automatically add page and line numbers.

It is the authors' responsibility to make sure the submitted files are fully viewable and in the intended format. The main manuscript file should be uploaded in PDF format.

The main manuscript file should always include all figures, tables, captions, and references, as well as author bylines (beneath the paper title). Author bylines are required by IEEE at all stages of the review process. The list of authors on the paper must correspond exactly to the ScholarOne Manuscripts submission: all authors should be included and in the same order. All figures and tables must be embedded in the text or added in the appendix of the paper (before references) with their captions, as shown in the template. References should be included at the end of the paper. If necessary, authors may add supplementary files that cannot be added to their papers by uploading them after the main manuscript file.

The first page of the paper should contain the paper title, full first and last names of all authors under the title. In the footnotes on the first page, please indicate in addition to the authors' full names their organizational affiliation, as well as whether the paper has been presented at a conference previously. If so, the conference name, dates, and location should be specified. Paper titles should avoid extraneous words such as "new" or "novel" that have limited search value. The corresponding author must be indicated clearly, along with the corresponding author's name, postal address, telephone number, and e-mail address. Please select the correct corresponding author in ScholarOne Manuscripts when submitting a paper. The first page should also contain an abstract of not more than 200 words. The abstract should not only indicate the subject and scope of the paper but should also summarize the authors' conclusion, so that it may be a useful document in an information retrieval system. The authors should provide a list of up to five keywords for indexing purposes.

Manuscript Length:

Authors should attempt to limit paper length so that, should it be accepted for publication in TTE, the final result is between 6 and 8 pages in length (including references). Papers exceeding 8 pages are subject to mandatory overlength page charges.

Regular papers exceeding 10 pages (including appendix and references) and review papers exceeding 12 pages (including appendix and references) may be rejected. The submission of papers in a series (Part I, Part II, etc.) on the same subject is normally discouraged as a matter of policy. In such cases, the authors may be asked to consolidate the work into a single submission.
